Open Session Board Minutes

The meeting was called to order by Mrs. Wareham, Board President, at 6:08 pm in the board room.

A motion to approve the agenda with amendments to include offering contracts for Mathematics and Language Arts teachers was made by Mrs. Carter. Motion carried 6-0.

No visitors were present.

A motion to approve minutes from the May 20, 2026 and May 27, 2026 meetings was made by Mr. Meredith. Motion carried 6-0.

Mrs. Drehle presented the financial information for May.

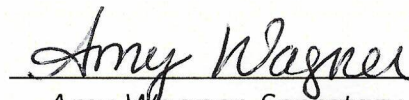
