Janna called the meeting to order at 5:30 p.m.

Tricia motioned to approve the agenda. Angie seconded. Motion passed.

No visitors.

Angie motioned to approve the minutes from the last meeting and the votes through messenger since the last meeting. Tricia seconded. Motion passed.

No correspondence.

Janette gave the Treasurer's report. Balance is \$12,298.83 with the proceeds from yesterday's Booster Club lunch. There will be a \$3300+ deposit from the Golf Tournament to be earmarked for scoreboards in the future.

Janna will do recognition of sponsors on Facebook. We will order a banner listing sponsors to be placed at the baseball field this spring and softball field in the fall.

Tricia motioned to approve Treasurer's Report. Angie seconded. Motion passed.

First 2 lunch fundraisers went ok. \$617 and \$723. Next one will be baked potatoes donated by Eddie in February.

Front row parking went over well again. \$1165 proceeds. \$1150 last year.

New Business:

Homecoming – Tricia motioned to approve the purchase of Homecoming royalty 'stuff'. Angie seconded. Motion passed. Around \$70 or \$75.

Senior Night will be February 6. Booster Club will buy bouquets again. It went over well during the softball senior night to split up the flowers among the seniors. It was decided to cap the total spent to \$5 per senior with seniors paying for any extra flowers they would like to present. Angie motioned for this. Tricia seconded. Motion passed.

### **Uniform Policy**

*Uniforms must be returned at the end of the season – no exceptions.*

*If a senior wishes to keep their uniform, the parent or student must notify the coach within one month after the season ends. Coaches will work with Administration and the Booster Club to determine whether a replacement uniform can be ordered or if a donation is possible due to upcoming uniform updates.*

*The cost of the replacement uniform must be paid at the time of ordering. Only one replacement order will be placed per sport.*

*Note: Seniors may not be able to keep their uniform if an identical replacement cannot be obtained.*
